# STATE EMPLOYEES' RETIREMENT SYSTEM OF ILLINOIS MINUTES OF THE RULES AND PERSONNEL COMMITTEE October 24, 2022

### PUBLIC COMMENTS

There were no members of the public present. Assistant to the Executive Secretary Jeff Houch introduced the new General Counsel for SERS to the members of the committee and briefly summarized her professional background.

## PROPOSED RULEMAKING

Assistant to the Executive Secretary Jeff Houch presented to the Committee two proposed rules. The first provision would codify that an installment plan agreed to between the System and a member purchasing optional service shall be in annual increments not more than 5 years.

The second provision proposes to amend its rule provisions to clarify that other forms of birth verification may be accepted only when a member submits documentation issued by a

representative of the member's birth state or county which states that the birth record for the member does not exist. The current process requires a "declaration from the state" that such birth record does not exist. Clarifying in this manner reflects the true characterization of such process.

Trustee Silverthorn made the motion to approve the proposed rules. Trustee Hawk seconded the motion, and the members voted in the following manner:
